<i>Broadband Action Team</i>	The Broadband Action Team is hoping to collect 100,000 speed tests by September 31 st , 2020. Speed test can be found here: https://connectourvalley.org/ Rhonda mentioned to take speed test multiple times, throughout the day.
<i>PIT Report</i>	Lance Larsen and Lee Murdock presented information about Point In Time count report. Lance mentioned he received a lot of feedback from PIT reports from previous years. Based on the feedback provided, Yakima County decided to conduct the 2020 PIT count internally relying on community support and the expertise of those who live in the area.
