NOTICE OF PUBLIC HEARING

Yakima County HOME Consortium (HOME)

NOTICE IS HEREBY GIVEN pursuant to Resolution No. 73-2021, the Board of County Commissioners of Yakima County, Washington that the Draft Yakima County 2019 Consolidated Annual Performance and Evaluation Report (CAPER) is available for public review and comment. Yakima County, in partnership with 8 cities and towns, receives approximately \$500,000 in federal funds from the US Department of Housing and Urban Development (HUD) each year to address goals and objectives identified in the Yakima County Consolidated Plan for Affordable Housing for 2015-2019 (Consolidated Plan). The CAPER includes a summary and evaluation of how these funds were used in 2019 to carry out the goals and objectives in the Consolidated Plan. The public is invited to review and comment on the Draft CAPER before Yakima County finalizes it and submits it to HUD.
