Proposed Text Changes to YCC Title 16C Yakima County Critical Areas Ordinance

NOTICE IS HEREBY GIVEN that pursuant to resolution number 211-2021 the Board of Yakima County Commissioners will conduct an open record public hearing on **TUESDAY, SEPTEMBER 28, 2021, at 10:00 a.m.**, or as soon thereafter, to consider text amendments to Yakima County Code (YCC) – Title 16C Critical Areas Ordinance (CAO). This hearing is on the proposed amendments to the flood hazard development requirements as a condition of Yakima County’s eligibility in the National Flood Insurance Program (NFIP), to be adopted or show evidence of adoption to ensure Yakima County’s floodplain management regulations are compliant with the standards of Paragraph 60.3(d) of the NFIP (file numbers LRN2021-00002/SEP2021-00015).
