A hearing regarding the challenge to the voter registration of Chelsea Dimas has been scheduled for Monday, November 22, 2021 at 4:30pm. at the Yakima County Courthouse / ballot processing center, 128 N 2<sup>nd</sup> St Room B-16, Yakima WA 98901.

A voter registration challenge hearing is an administrative hearing, not a court proceeding, and will be open to the public. The County Canvassing Board will preside over the hearing.

This hearing provides an opportunity for Ms. Dimas and for you to present evidence to determine the validity of Ms. Dimas' registration. You can participate in person or by submitting additional written testimony by declaration. A sample declaration is enclosed and must be received in our office prior to the hearing. If you do not participate in the hearing, a decision will be made based on available information and you will be contacted regarding the outcome of the hearing.
