NEW BUSINESS	Melissa Holm introduced herself as the new Program Coordinator for the Yakima. Esther Magasis gave an update about the Yakima County Care Campus. There are two research: local research and model research. The Criminal Justice Sequential Intercept Model will be finalized towards the end of September. The Homeless Response System model is planned for November and the Critical Intervention Mapping for Youth will be finalized in January.
YCCC	The Yakima County has secured an intern for the next few months from the University of San Francisco. Lilly Dickens will assist with researching models of care for Yakima County Care Campus.
Five Year Strategic Plan	There was a conversation about the Five-Year Strategic Plan. Some of the answers from the polling question included COVID has had an impact on the Five-Year Strategic Plan outcome as well as identifying what the goals are. ERAP	The Emergency Rental Assistance Program (ERAP) grant ended on June 30th, 2021. Esther gave her gratitude to the six partner agencies who were able to distribute almost \$2.9 million in rental assistance. Rental assistance is still available for eligible households.
