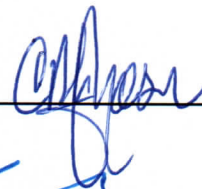

Report to the Canvassing Board

Required recount – County Commissioner; District 3

General Election – Yakima County, Washington – November 2, 2021

The required hand recount of 40,843 ballots for Yakima County Commissioner District 3 resulted in a net change of 1 vote between the candidates.

Description of differences from original count

1

In the following precincts, the response position for *Autumn Torres* was selected with a line drawn through the candidate's name with no new choice. Washington State Voter Intent Standards, under Rule C example 2b, addresses this type of mark as being not a valid vote for a candidate and should be adjudicated as an undervote. These instances were not caught during the initial visual inspection of ballots prior to scanning. Therefore, it was read as a vote for candidate Torres rather than having been adjudicated as an undervote. Amended results reflect the following, for a loss of three (3) votes for candidate Torres.

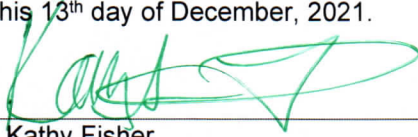

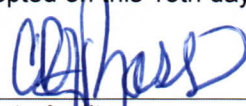
