JOB SUMMARY: The Solid Waste Class A Driver II performs journey level activities related to Solid Waste Operations.			
DISTINGUISHING CHARACTERISTICS: Solid Waste Class A Driver II is the elevated level class of the Solid Waste Class A Driver classification series. The Solid Waste Class A Driver II class is distinguished from the Solid Waste Class A Driver I class by the ability to proficiently operate the loader in the transfer station and loading out various commodities and proficiently operate the transfer station crane.			
DUTY NO.	ESSENTIAL DUTIES: (These duties are a representative sample: (Position assignments may vary.)		BAND/ GRADE
1	Operates a loader and stationary crane, Class 8 (over 33,000 GVWR) truck with tandem drive, drop axle and 5 th wheel pulling a 53-foot tri-axle walking floor transfer trailer with the purpose of transporting refuse from the transfer station to the designated landfill. Removes snow and sands roads; waters landfill roads for dust abatement; hauls compost or wood chips, gravel, sand and other materials.		B2
2.	Operates the loader in the transfer station loading transfer trailers, pushing up garbage, ensuring a safe operating distance from customers. Loads wood chips, compost, white goods, and tires into various vehicles and trailers for transport. Operates the stationary crane in the transfer station to load out and pack transfer trailers.		B2
3.	Operates a variety of equipment such as semi-trucks, sand trucks, water trucks, forklifts, alternate daily cover spray machine, and roll off bin trucks. Performs complete pre- and post-operation inspection of the vehicle; reports needed equipment repairs and may call out for minor repairs such as flats or hydraulic line failures.		B2
4.	Transports and exchanges recycling roll of bins at various locations; transports and exchanges garbage roll of bins.		B2
5.	Performs minor repairs to equipment, such as tarps, or assists maintenance workers if needed. Continuously monitors waste for evidence of unacceptable waste.		A1
6.	Maintain adherence to required productivity standards to ensure material is transported in a timely manner and load counts are met.		B2
7.	Courteously interacts with the public, commercial garbage haulers, to ensure safety within the transfer station and landfill areas; explains solid waste policies, regulations, and ordinances; refers difficult issues to supervisor.		B2
8.	Performs other duties as required.

Skills: (Position requirements at entry):

- Operating trucks, walking floor trailers and other equipment, such as loaders, stationary crane, forklifts, water trucks, sand trucks and snow plows;
- Using two-way radios and other communicative devices;
- Performing preventive maintenance on equipment;
- Applying customer service techniques;
- Establishing and maintaining effective interpersonal relationships with co-workers, other departments, commercial garbage haulers and with the public;
- Communication, both oral and written, sufficient to exchange or convey information and to receive work direction.

Training and Experience: (Position requirements at entry):

High School Diploma or General Equivalency Diploma (GED) and five years equipment operation, road maintenance and/or construction experience and operation of a loader; or an equivalent combination of education and experience which provides knowledge, skills, and abilities sufficient to successfully perform the essential duties of the job. Must be able to proficiently operate a loader.

Licensing Requirements: (position requirements at entry):

Required:

- Valid Washington State Class A Commercial Drivers License with Air Brakes and Tanker Endorsements (No automatic restrictions)
- Successful completion of general employment verification
- Pre/Post Employment Drug Testing
- Consent for queries of the Federal Motor Carrier Safety Administration (FMCSA) Drug and Alcohol Clearinghouse to comply with Federal Regulations (49 CFR Part 382)

Preferred: Solid Waste Experience

Working Conditions: Position may have the potential exposure to the following:

Environment: Excessive noise, exposure to weather, extreme temperatures, moving/mechanical parts, pathogen exposure, vibration, travel. work in locked down facilities, field work, exposure to hostile/angry individuals, work outside of standard business hours and multiple work locations;

Physical Demands: bending, carrying, handling, lifting, reaching, sitting, standing, walking, fingering, balancing, climbing, crawling, crouching, kneeling, hearing, smelling, talking, visual acuity.

Intellectual Demands: ability to multitask, confidentiality, ability to work under pressure, ability to articulate and communicate in conversations, ability to follow written and verbal instruction.

Heavy Work: Exerting up to or in excess of 100 pounds of force occasionally, and/or up to 50 pounds of force frequently, and/or up to 20 pounds of force constantly to move objects. Work is performed out in the field.
