JOB SUMMARY: The Mechanic II performs journey level activities in the maintenance and repair of county automotive and heavy equipment; designs and fabricates equipment parts; and provides technical assistance to others.			
DISTINGUISHING CHARACTERISTICS: The Mechanic classification series is distinguished from other maintenance classes by specialized knowledge and skill in automotive maintenance and repair required for full performance of the job. The Mechanic II is distinguished from Mechanic I classification based on the necessity for a Commercial Driver's License Class A with Airbrake and Tanker endorsements.

- Operating tools and equipment used in repairing gas and diesel engines and in performing related duties;
- Operating equipment for testing purposes due ensure proper function before and after use and in good working order;
- Establishing and maintaining effective interpersonal relationships at all organizational levels and with internal and external customers and vendors;
- Communication, both oral and written, sufficient to exchange or convey information and to receive work direction.
- Using two-way radios and other communications devices;
- Applying customer service techniques;

Training and Experience: (Position requirements at entry):

High School Diploma and 6 years of automotive and/or heavy equipment maintenance and repair or an equivalent combination of education and experience which provides knowledge, skills, and abilities sufficient to successfully perform the essential duties of the job.

Preferred: Associates Degree in diesel technology or related field from an approved automotive program and 4 years automotive and/or heavy equipment maintenance experience.

Licensing Requirements: (position requirements at entry):

- Valid State of Washington Driver's License with CDL endorsement; Commercial Driver's License with Airbrake and Tanker Endorsements.
- Ability to obtain a valid State of Washington Flagger Certification required for County Road assignments within 30 days of hire.
- Successful completion of general employment verification
- Consent for queries of the Federal Motor Carrier Safety Administration (FMCSA) Drug and Alcohol Clearinghouse to comply with Federal Regulations (49 CFR Part 382).

Working Conditions: Position may have the potential exposure to the following:

Environment: Excessive noise, exposure to weather, extreme temperatures, moving/mechanical parts, pathogen exposure, vibration, travel. work in locked down facilities, field work, exposure to hostile/angry individuals, work outside of standard business hours and multiple work locations;

Physical Demands: bending, carrying, handling, lifting, reaching, sitting, standing, walking, fingering, balancing, climbing, crawling, crouching, kneeling, hearing, smelling, talking, visual acuity.

Intellectual Demands: ability to multitask, confidentiality, ability to work under pressure, ability to articulate and communicate in conversations, ability to follow written and verbal instruction.

Heavy Work: Exerting up to or in excess of 100 pounds of force occasionally, and/or up to 50 pounds of force frequently, and/or up to 20 pounds of force constantly to move objects. Work is performed out in the field.
