**DESCRIPTION OF PROPOSAL**

**Parcel Numbers:** County Wide

**Proposal:** The Board of Yakima County Commissioners (BOCC) will hold two open record public hearings on the following:

Agritourism: Yakima County Code (YCC) Development Regulation Text Amendment to amend YCC 8.10 Outdoor Festival Regulations, YCC 19.01.070 Definitions, YCC 19.14-1 Allowable Land Use Table, YCC 19.18.060 Agricultural Tourist Operations, and add 19.18.500 Wineries, Breweries, and Distilleries as a new section. The text amendments will clarify the current regulations. This proposal will make it easier for applicants to anticipate what is included in the permits process and requirements while adhering to the framework of the state's Growth Management Act ensuring continued protection for agricultural zones and support for rural communities and tourist industries.
