

A MESSAGE FROM YOUR COUNTY ASSESSOR

I am pleased to share this information with you, the residents of Yakima County. I endeavor to continue the transparency of information and data and to keep the office available to the public that has been present and will continue to improve upon the information available.

The primary role of the Assessor is to determine the true and fair value of locally assessed properties. Those values are used to calculate property taxes for the county, cities, library, fire departments, ports, roads, schools, and other special districts. The Assessor's role is not to determine the amount of taxes required but to limit them in accordance with state laws. The County Treasurer bills and collects the required taxes based on those calculations.

This tax year, despite the market value growth from sales in the 2022 calendar year, over 36% of properties will have a smaller tax bill. Once voted for lid lifts and levies are excluded from the growth the percentage of decreased tax bills is over 40%.

It is my honor, together with my office, to assist all property owners and to make sure they are treated fairly, and that all property is valued equitably. It is my sincere hope that you find us helpful, efficient, and courteous.

We have several programs available to assist you online and intend to expand upon those services and continue to make them better. Please let us know at any time if you have suggestions or ideas about the information we publish or if you have questions about property data. We are here to serve and support the citizens of Yakima County and look forward to helping you.

How Your Assessor Appraises Property

The Assessor is required by law to physically inspect each property once in a 6-year period. We refer to these inspection periods as cycles. Each cycle pertains to a certain area of Yakima County, for Residential and Agricultural properties, and a certain business type for Commercial properties. There are three methods of value used to value property, they are as follows: comparative sales, the cost approach, and the income method. These approaches can be used separately or combined to determine a true and fair value for each individual property. The goal of the Assessor is to bring all property to its true and fair marketable value no matter which method of value is used.

The Comparative Sales Method

Accredited appraisers acting on behalf of the Assessor are sent out to locate properties that have recently been sold, they determine whether each sale is valid based on state guidelines and the conditions of the sale. Once sales verification has been completed, the data can be used to determine the value of similar properties by comparison. Appraisers verify the characteristics of each property to ensure the equitability in value for these similar properties.

The Cost Approach

How much would it cost to build a property if it needed to be rebuilt? That is the simplest way to explain the cost approach. Labor, material costs, and depreciation are all applicable in calculating value with the cost approach. Appraisers, during each cycle inspection, are sent to properties to verify property characteristics so that the cost associated with the property is as accurate as possible. These cost values are adjusted for the Yakima area.

The Income Method

The income approach, sometimes referred to as the income capitalization approach, is a type of real estate appraisal method that allows investors to estimate the value of a property based on the income the property generates. It's used by taking the net operating income (NOI) of the subject's rent collected and dividing it by the capitalization rate derived from the market.

Personal Property

All businesses in the state of Washington must be appraised for the value of their personal property for the purpose of taxation. Personal property is a self-reporting system determined by the cost approach. The amount for which an item was purchased will be valued at cost, less depreciation. The depreciation of these items is pre-determined by the Department of Revenue for Washington state. The values are updated annually, and the deadline for filing a personal property listing is April 30th of each year.

Senior Citizen and Disabled Person Exemption

A reduction of tax is available for senior citizens 61 years of age or older as of December 31st, disabled persons who are retired from regular gainful employment because of such disability, veterans with a service-connected disability rated at more than 70% or for a surviving spouse/registered domestic partner who is 57 years of age or older and the spouse/registered domestic partner had been receiving the exemption at the time of death. The applicant must also meet the income requirements of under \$40,000 gross income, including social security and other types of income not taxed by the IRS, and live in the home for at least six months each year.

Open Space Taxation Act (RCW 84.34)

This law directs the taxing of farm and agricultural land that is being commercially farmed. There are varying gross income qualifications based on the size of the property. When a property is in the program it is valued at the in-use value, not the market value. To secure the benefits from this act, the owner must apply along with a filing fee by December 31st. Once the land is classified as farm and agriculture property, it will continue in the classification unless a change of use or sale occurs. The Assessor's office will make periodic income and physical inspection checks to ensure that the eligibility continues for the classification. The classification can be transferred when the property changes hands but only if the new owner assumes the liability. If there is a change in use or a new owner does not wish to assume the liability an additional tax will be assessed. The additional tax is calculated on the difference between taxes paid under the lower current use value and the amount that would have been paid at full market value for the current and previous seven years. Additionally, interest is added at a rate of 1% per month from the date of removal.

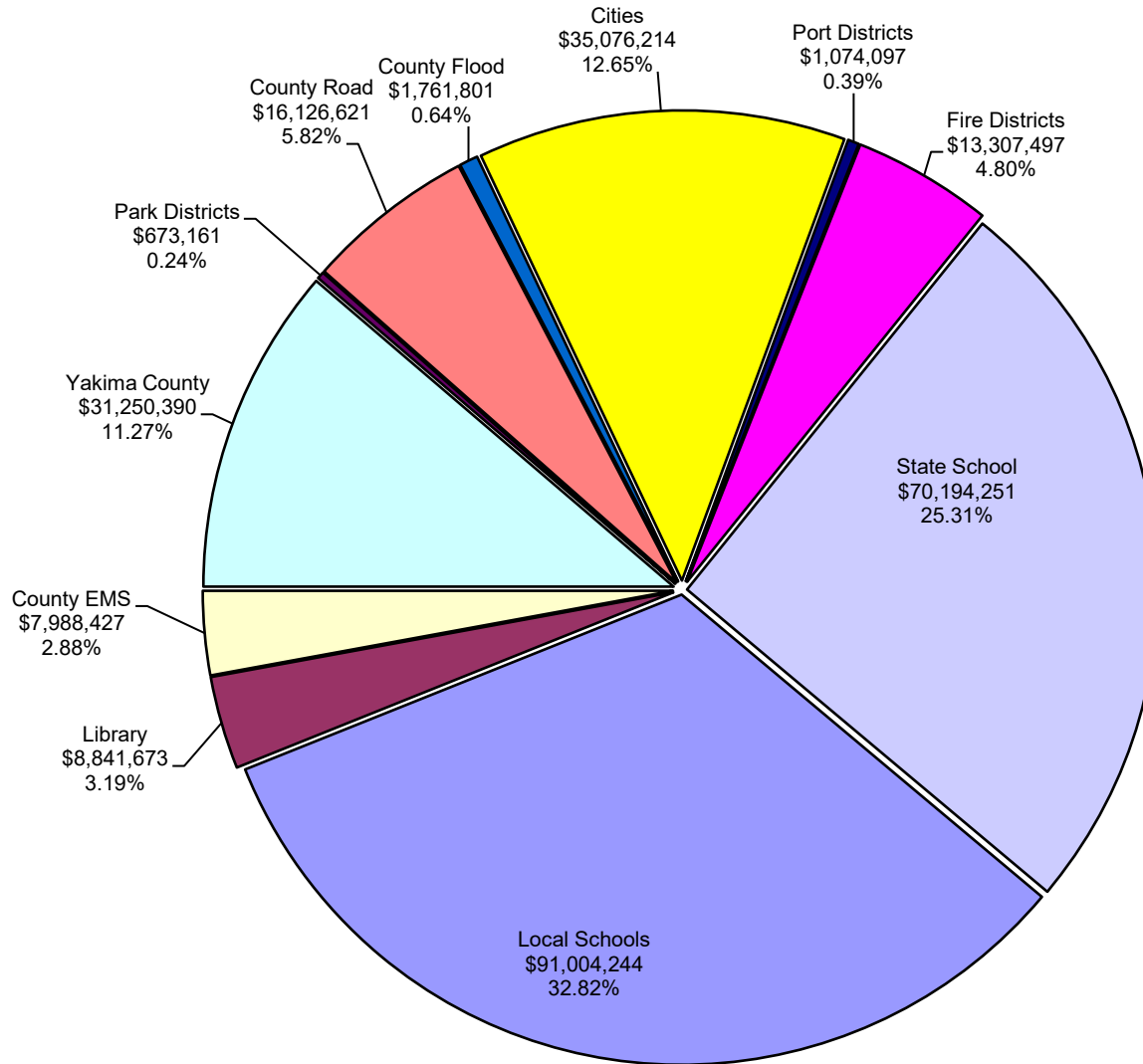

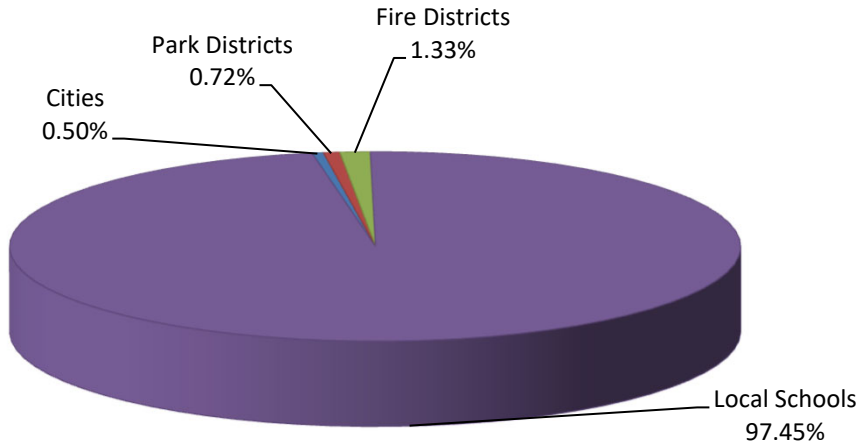

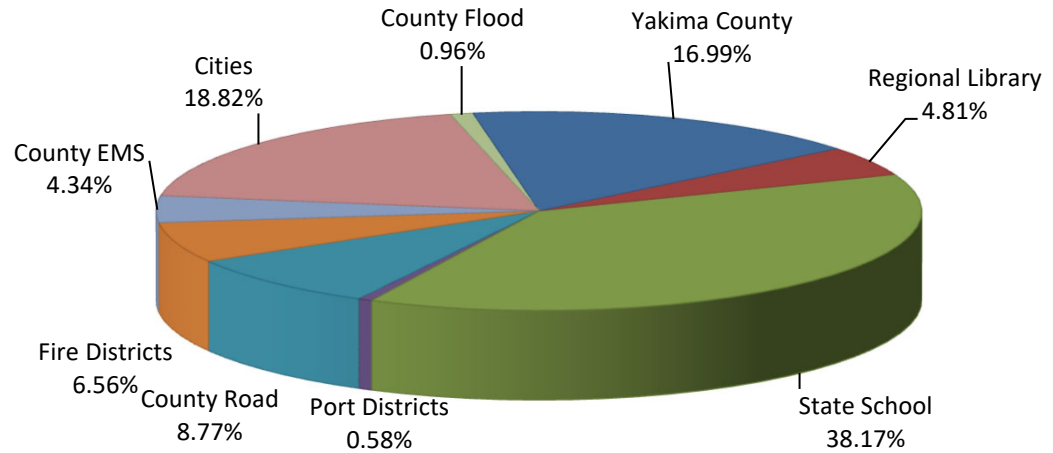


2024 Excess Tax Dollars
