Yakima Neighborhood Health Services Housing and Essential Needs 2025 Contract Modification 1 (YNHS-HEN-2025-MOD1)

Background Information:

Yakima Neighborhood Health Services was awarded \$707,500 for their year 1 Housing and Essential Needs (HEN) contract. This modification increases their year 1 award by \$54,135, bringing the total year 1 award to \$761,635 and leaving year 2 unchanged. The additional funding, Foundational Community Supports (FCS) From the State Department of Commerce provides a bridge period for households who are no longer HEN eligible. YNHS is one of two eligible grantees.
