Grace City Outreach, Outreach 2025 Contract Modification 1 (GCO-Outreach-2025-MOD1)

Background Information:

Grace City Outreach requested \$85,920 (per year) in the 2024-26 HHAP RFP for Outreach. Grace City Outreach was awarded \$29,331. This modification increases their year 1 award by \$56,589 bringing the total year 1 award to the full requested \$85,920 and leaving year 2 unchanged. The additional funding is from one-year non-recurring funds granted by the State Department of Commerce.
