Generating Hope Outreach 2025 Contract Modification 1 (GH-Outreach-2025-MOD1)

Background Information:

Generating Hope requested \$16,470 (per year) in the 2024-26 HHAP RFP for Outreach. Generating Hope was awarded \$5,623. This modification increases their year 1 award by \$10,847 bringing the total year 1 award to the full requested \$16,470 and leaving year 2 unchanged. The additional funding is from one-year non-recurring funds granted by the State Department of Commerce.
