Grace City Outreach Shelter 2025 Contract Modification 1 (GCO-Shelter-2025-MOD1)

Background Information:

Grace City Outreach requested \$541,920 (per year) in the 2024-26 HHAP RFP for Shelter. Grace City Outreach was awarded \$225,000. This modification increases their year 1 award by \$316,920 bringing the total year 1 award to the full requested \$541,920 and leaving year 2 unchanged. The additional funding is from one-year non-recurring funds granted by the State Department of Commerce.
