Background Information:

Generating Hope requested \$75,620 (per year) in the 2024-26 HHAP RFP for Shelter. Generating Hope was awarded \$60,000. This modification increases their year 1 award by \$15,620 bringing the total year 1 award to the full requested \$75,620 and leaving year 2 unchanged. The additional funding is from one-year non-recurring funds granted by the State Department of Commerce.

\$15,620 from July 1st, 2024, through June 30th, 2025.


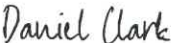
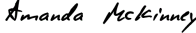
