Triumph Treatment Services Shelter 2025 Contract Modification 1 (TTS-Shelter-2025-MOD1)

Background Information:

Triumph requested \$122,078 (per year) in the 2024-26 HHAP RFP for Shelter. Triumph was awarded \$100,000. This modification increases their year 1 award by \$22,078 bringing the total year 1 award to the full requested \$122,078 and leaving year 2 unchanged. The additional funding is from one-year non-recurring funds granted by the State Department of Commerce.
