Yakima Neighborhood Health Services Housing and Essential Needs 2025 Contract Modification 2 (YNHS-HEN-2025-MOD2)

Background Information:

Yakima Neighborhood Health Services was awarded \$761,635 for their year 1 Housing and Essential Needs (HEN) contract. This modification increases their Year 1 award by \$245,408 bringing the total for Year 1 to \$1,007,043, while leaving Year 2 unchanged. The additional funding, comes from excess funds allocated to Yakima County program costs that are not being utilized this year due to the availability of other funding sources.
