WHEREAS, on August 29, 2025, Yakima County Superior Court entered judgments in favor of Plaintiffs AgWest Farm Credit, FLCA (formerly known as Northwest Farm Credit Services, PCA)("PCA"), as follows:

1. Default Judgment (FLCA) in the amount of \$447,187.58 with interest on the principal amount at the rate of 10.40 percent per annum until paid in full;
2. Default Judgment (PCA Loan -3453) in the amount of \$9,668.18 with interest on the principal amount at the rate of 8.70 percent per annum until paid in full;
3. Default Judgment (PCA Loan-0121) in the amount of \$146,243.82 with interest on the principal amount at the rate of 9.60 percent per annum until paid in full;
4. Default Judgment (PCA Loan-0122) in the amount of \$53,080.51 with interest on the principal amount at the rate of 9.60 percent per annum until paid in full.
