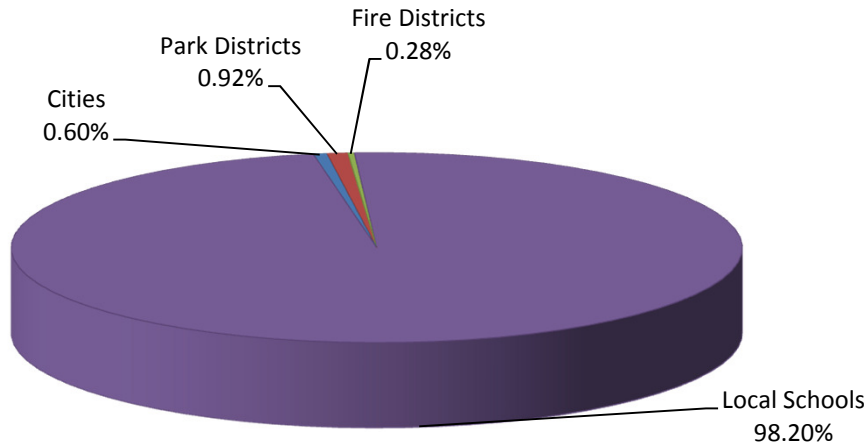

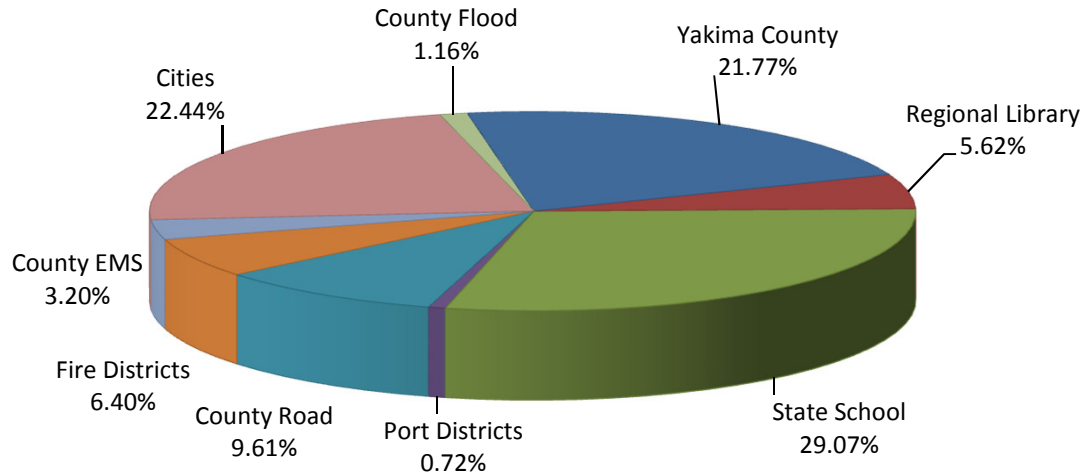

2016 Excess Tax Dollars



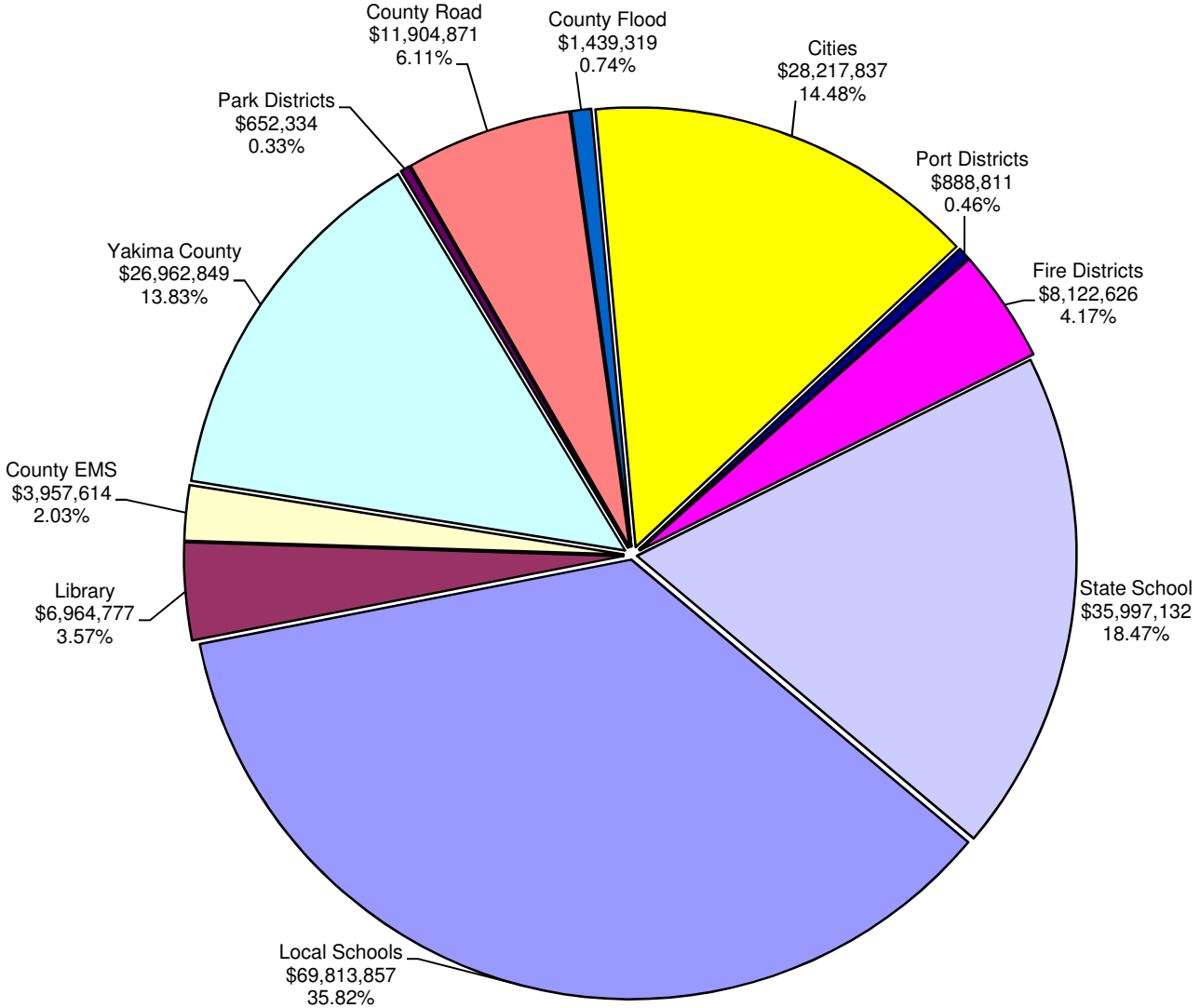
